



#### Greetings,

In my message this past Sunday I made the statement that the church is under attack. The reason the church is under attack is because the church has the truth and we live in a world where people want their version of the truth. A large portion of society has turned away from the truth of the church and are pursuing their own ways. It has come to the point where many in the world wants to run from God and do what the sinful heart longs to do.

I talked Sunday about Grace Community Church in Los Angeles and how their pastor, John MacArthur had defied the government and was having church during the pandemic. I talked about how MacArthur had threatened MacArthur with jail and large fines if he didn't comply with their demands to stop having church. He defied the government and took them to court where he won. The court agreed that they had a constitutional right to have church and that the government did not have the right to stop them.

Grace Community Church is a large church and the city has a parking lot adjoining the church parking lot and Grace Community has leased the city parking lot for the past 45 years. This past Sunday the city terminated the lease and served them with an eviction notice.

Thomas More Society special counsel Jenna Ellis said in a statement to **the** Todd Starnes Show; "Los Angeles County is retaliating against Grace Community Church for simply exercising their constitutionally protected right to hold church and challenging an unreasonable, unlawful health order."

When we read about these things, we think that it would never happen here. I am sure the people at Grace Community thought the same thing. As Christians we have let the government take God out of our Schools, the Ten Commandments out of our courthouses, our nativity scenes out of the town square.

At what point do we decide to take a stand?? At what point do we stand united as Christians and say enough is enough?

As I said in my message Sunday it is time for us to speak out. It is time for us to take a stand. It's time for Christians to unite and stand for our God given rights.







CALL TO ORDER: Mitchell Jank called the meeting to order. Johnny Jank opened the meeting with a devotion on the purpose of government with the right being the government of God and the left being the government of power. There is an allegiance to government as well as allegiance to God, faith and works, with a working relationship between religion and politics.

**MINUTES:** Reviewed, Motion to accept by Marv Sager, 2<sup>nd</sup> by Archie Abrameit, and approved.

#### **PASTOR'S REPORT**

It is with grateful hearts that we announce the hiring of JoLynn Meadows as our Executive Director of Victoria House of Palms, a residential home for pregnant women.

JoLynn Meadows, a native of Victoria, has dedicated twenty- eight years of love and service to young girls and women in their childbearing years at a crisis pregnancy center in Mobile, Alabama. She has returned to Victoria to join with the VHOP Board and Pastors Jim and Tamara Graff to provide programs of excellence to Teen Moms to achieve the goals of a high school diploma and beyond. All of this will be achieved in a loving, Christian, confidential and non-judgmental environment.

This process has been very long and at times we were so disheartened. It seemed that the devil himself was keeping us from opening this much needed home for pregnant teens.

First a hurricane, then we had the home done, furnished by the Streiff family of Ashley's Furniture. We only had to hire an Executive Director and on the surface it seemed so easy. But as they say that was not the end of the story.

The State of Texas is very vigilant and strict when it comes to underage children. Their job description was almost impossible for us to find the right person. We tried and kept failing. We came up with an idea that was a bit different and we found success in JoLynn Meadows. We decided to take teens who were 18 and older so that these young women were looked upon as adults, not minors. The mountain of state requirements we had to climb suddenly became attainable.

JoLynn has been on the job a month and we look forward to hearing great things from her. She is making the right connections and we will keep you in the loop.

Once more, thank you for supporting us through all of this. You were there with prayers, monetary support and understanding. We cannot wait to have our first teen walk through those doors!

Proposal by Power Clean to wash down exterior walls of church and parish hall.

#### **Renovation Progress:**

Called meeting of June 29<sup>th</sup> included report by consultant Tim Westphal. Primary discussion was related to his concern regarding perceived shallow cover over the elevator landing's structural steel rebar grid, based on photos taken prior to the concrete pour. Also discussed was possible lengthening of sanctuary door threshold to alleviate the tripping hazard posed by the existing threshold. Following discussions with Tim, team members present discussed potential alternatives for achieving the originally preferred solution, while also mitigating the impact of the currently existing cover over the rebar. As reported previously, soil removal and grading in preparation for topsoil infill have been

done, and a layer of topsoil spread over most of the construction area. Additional topsoil application and grading, along with limestone topping on the driveway approach to the drop-off area remain, pending scheduling availability of volunteers. Following placement and grading of additional topsoil, the area will be ready to sod. Team still plans to use services as bid by Chance Dukes to pick up and plant the grass.

Discussions with Roth Construction, along with RMA involvement, continue to be ongoing in efforts to resolve construction issues with elevation and grade on the elevator landing and elevator approach flatwork, as well as numerous unaddressed Punch List items.

Approximate Current Renovation Fund Status: \$550,000

Next Regularly Scheduled Meeting – August 9<sup>th</sup> at 8:00 am

**DISCUSSION:** Stakes have been placed to designate the areas to be filled with topsoil and limestone in the church's yard and driveway area. Dunn's Services will work on the limestone placement and Dukes' nursery will put in the soil and plant the grass.

#### **WORSHIP TEAM REPORT**

#### ADDITIONAL DISCUSSION ITEM

The family of Johnny Pokluda has requested a plot for him on St John's Cemetery. A motion was made by Linda Ruschhaupt to sell a plot to the family for Johnny with the reservation of the plot next to him for Laurie. Motion was seconded by Marv Sager and passed by the members of council present.

The air conditioner thermostat on the left side of the church needs to be checked.

There being no further business to discuss, the meeting adjourned with the Lord's Prayer.
